ON TODAY'S DATE THIS WRITER MET WITH VI/CO (PALOW, DENNIS),A TOWN BOARD MEMBER IN BERNE, AND WITH PERSON INTERVIEWED (LYONS, SEAN) THE CURRENT TOWN SUPERVISOR FOR BERNE. VI/CO (PALOW) REPORTED THAT BEGINNING AROUND JANUARY 2018, S1 (WILLSEY) A TOWN BOARD MEMBER HAS BEEN MAKING HARASSING, SLANDEROUS, AND DEFAMATORY STATEMENTS ABOUT HIM TO OTHER BOARD MEMBERS, TOWN RESIDENCE, AND PUBLICLY.

SPECIFICALLY, VI/CO (PALOW) STATED THAT IN AN EMAIL THAT SI (WILLSEY) SENT OUT TO THE MEDIA AND OTHER TOWN BOARD MEMBERS HE DESCRIBES VI/CO (PALOW) AS DANGEROUS, IRRATIONAL, ANGRY, CAPABLE OF KILLING, HAVING PTSD, AND A THREAT TO THE PUBLIC BECAUSE OF HIS COMBAT TOURS AND TIME IN THE MILITARY SERVICE. A COPY OF SAID EMAIL WAS SECURED.

SI (WILLSEY) HAS DISCLOSED VI/CO (PALOW)'S PRIVATELY DIAGNOSED PTSD THE PUBLIC WITHOUT VI/CO'S CONSENT TO DO SO. SI (WILLSEY) IS DISCRIMINATING AGAINST VI/CO (PALOW) FOR BEING A COMBAT VETERAN AND TREATING HIM POORLY SPECIFICALLY BASED ON BEING A VETERAN WHILE MAKING SLANDEROUS AND DEFAMING STATEMENTS ABOUT HIM. VI/CO (PALOW) STATED THAT HE FEELS HARASSED, AND FEARFUL FOR HIS SAFETY AND HIS FAMILIES SAFETY AT THIS POINT BASED ON HOW SI (WILLSEY) IS DESCRIBING HIM TO THE PUBLIC.

PERSON INTERVIEWED (LYONS) STATED HE FEELS NO THREAT OR HARM BY WORKING WITH VI/CO (PALOW) AND THAT SI (WILLSEY) IS HARASSING AND DISCRIMINATING AGAINST VI/CO. PI (LYONS) STATED THERE WAS A SPECIFIC INCIDENT WHERE SI (WILLSEY) BROUGHT VI/CO (PALOW) A HOLIDAY GIFT WHICH VI/CO RESPECTFULLY DECLINED ACCEPTING, AND SI (WILLSEY) BEGAN YELLING IN VI/CO'S FACE. PI (LYONS) STATED THAT HE HAD TO ADVISE SI (WILLSEY) TO STEP BACK AND TO LEAVE THE ROOM.

VI/CO (PALOW) REQUESTS THAT THIS BE DOCUMENTED AND THAT HE WILL PURSUE CIVIL OPTIONS AGAINST SI (WILLSEY) FOR THE DESCRIMINATION AND HARASSMENT THROUGH HIS SLANDEROUS COMMENTS.
